The Company redeemed all of the remaining convertible bonds (the “**Bonds**”) due February 2021 held by Skyland Circle Technology Limited (the “**Bondholder**”) in the principal amount of HK\$48,210,000 in December 2020 (together with the early redemption of the Bonds held by the Bondholder in November 2020 as “**Early Redemptions**”) pursuant to the terms and conditions of the Bonds (for details please refer to the Company’s circular dated 24 March 2020). Prior to the Early Redemptions in November and December 2020, the Bondholder originally held the Bonds in the principal amount of HK\$60,000,000. All of the outstanding Bonds held by the Bondholder were fully redeemed after the Early Redemptions.
